GUARDIANSHIP FEE SCHEDULE - 2019

CoG's fees are subject to change annually at the discretion of the CoG Board of Directors.

INACTIVE GUARDIANSHIP FEES	
<i>These fees apply to clients in which CoG has been named recommended Successor Guardian in a legal document, but CoG is not yet actively serving as Guardian.</i>	
Fees	Amount & Description
Inactive Guardianship Fee (applied annually)	<p>\$50 annually</p> <p><i>The Inactive Guardianship Fee covers the administrative time to set up the client file and to update client information on an annual basis. This annual fee is due upon CoG being named in a legal document and invoiced every December thereafter.</i></p>
ACTIVE GUARDIAN OF THE PERSON - INITIAL FEES	
<i>These fees apply to clients for whom CoG has been appointed Guardian of the Person.</i>	
Fees	Amount & Description
Activation Fee (one-time fee due upon CoG being appointed as Guardian of the Person)	<p>\$1,500 one-time fee</p> <p><i>The Activation Fee covers the initial consultation and intake meetings with CoG staff and the client and/or their representative and attendance at the Guardianship hearing.</i></p> <p><i>CoG will include up to 2 hours of our legal counsel's time in the Activation Fee. If our legal counsel spends more than 2 hours on an intake, an hourly rate of \$250/hr will be applied above and beyond CoG's Activation Fee.</i></p>
ACTIVE GUARDIAN OF THE PERSON - ONGOING FEES	
<i>These fees apply to clients for whom CoG has been appointed Guardian of the Person.</i>	
Fees	Amount & Description
Hourly Fees – Care Management (applied monthly in tenths of an hour increments)	<p>\$150 per hour</p> <p><i>Care Management Fees are applied to clients for whom CoG is actively serving as Guardian of the Person. This fee covers health care decision-making and advocacy, regular assessments of the client's needs, monitoring of care and services, review of existing support services, linkage to needed services, and crisis intervention.</i></p>

ACTIVE GUARDIAN OF THE ESTATE OR GENERAL GUARDIAN FEES

These fees apply to clients for whom CoG has been appointed Guardian of the Estate or General Guardian.

Fees	Amount & Description
Commission (applied annually)	Amount varies <i>CoG may receive commission for handling of the client's estate under a General Guardianship or Guardianship of the Estate. The amount or method of compensation is set by the Clerk of Superior, in the clerk's discretion, up to, but not to exceed five percent (5%) of the qualified estate receipts and disbursements. The clerk will consider time, responsibility, trouble, and skill involved in the management of the estate. Commissions are accounted for as costs and expenses of administration. CoG must petition the clerk for approval of a commission or additional reimbursement for out of pocket expenses before making distribution of that commission.</i>
